To be referee at coming European Championship

For next EC in Georgia 2020 we will invite all A-category referees (decision by the GA in Vilnius). To coming EC in Rumania 2020 (prel) all EKO referees are invited. In both cases an application with an approval must be done before the championship. For the Open category EC in Lithuania 2020 (prel) decision has to be done.

New EKO Referees

The Referee Committee can announce that the following persons are given EKO Kumite Referee licenses. There are persons that have challenge for new licenses but not got a new license. In some case they need better score in the test or more experience.

To get higher quality of our kata referee education we will now work in this manner. The kata referees will have the same categories as kumite referees A, B and C. The licenses will be based on the following steps.

- 1. Application with a compulsory CV of the referee background.
- 2. Show understanding on how the kata should be performed.
- 3. Theory rule test and judgment test through video clips.
- 4. Practical refereeing.

Team kata

The project with team kata will be disused at next board meeting with a proposal to soon be an official EKO championship category. All judgement will be the same as individual but with the ad of synchronization.

Ranking for selection of fighters to World Championship in Poland Next EC in Georgia will be the first step to select fighters for next WC 2021, more information will be given after next EKO board meeting.

Selection tournament for WFKO World Championship

In January 18-19 the EFKO will be established and selection to coming WFKO World Championship 2020 in May will be held in Antwerp, Belgium. Invitation for the tournament is already on the web. All EKO license referees are welcome to apply for participating. More information will be given in middle of November.

News from the Medical Committee

In 2019 we have change EKO Health Information document. It is the document that must be used before tournaments. The change has made it less comprehensive and will be easier to fill out for the fighters and for the doctor who does the health check in the fighter's home country before the competition.

We are very aware of the safety of the fighters. That is why we have made various proposals to the EKO Referee Committee. Among other things, we have suggested more attention to concussions. Many people assume that concussions involve a loss of consciousness, but that is not true. In many cases, a person with a concussion never loses consciousness.

There are clear rules for fighters who get hit in the head with a legal technique. If this fighter is not ready in 3 seconds, the fighter loses the fight. Then EKO Medical

Committee recommend that the fighter to be inspected by the tournament doctor. Here the tournament doctor can assess whether the fighter should

- 1. Have information on concussion signs and have provided the EKO Medical Committee concussion brochure.
- 2. Depending on the signs of concussion, possibly re-examined by the tournament doctor at agreed intervals.
- 3. may be hospitalized for further examination and observation.

We believe there is a potential problem, when a fighter gets hit in the head with an illegal technique.

In the case of a concussion, because of an illegal technique, we do not have clear rules. It is in these cases that we want more attention for the safety of the fighters. This is something referees, coaches and fighters needs more information about.
